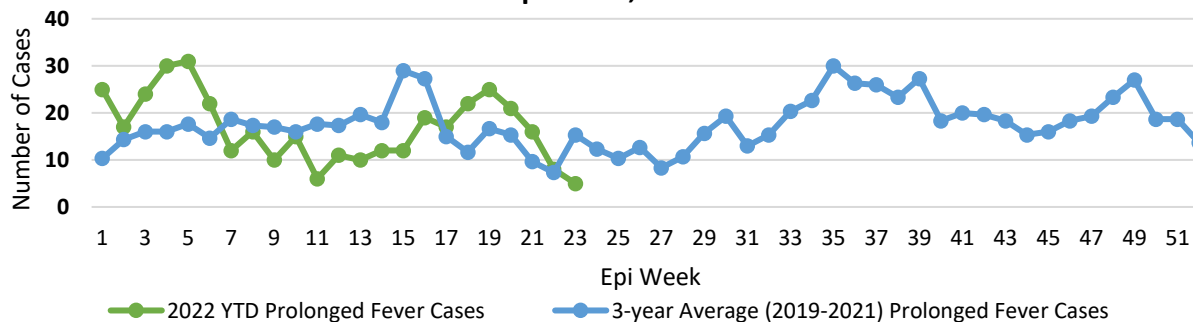

- **6% Increase** in **Total Encounters** from the last epi week to the current epi week.
- **29% Increase** in **Influenza-like cases** was seen this epi week (#23) compared to the average of the previous 3 epi weeks (#22, 21, & 20).
- **67% Decrease** in **Prolonged Fever cases** was seen this epi week (#23) compared to the average of the previous 3 epi weeks (#22, 21, & 20).

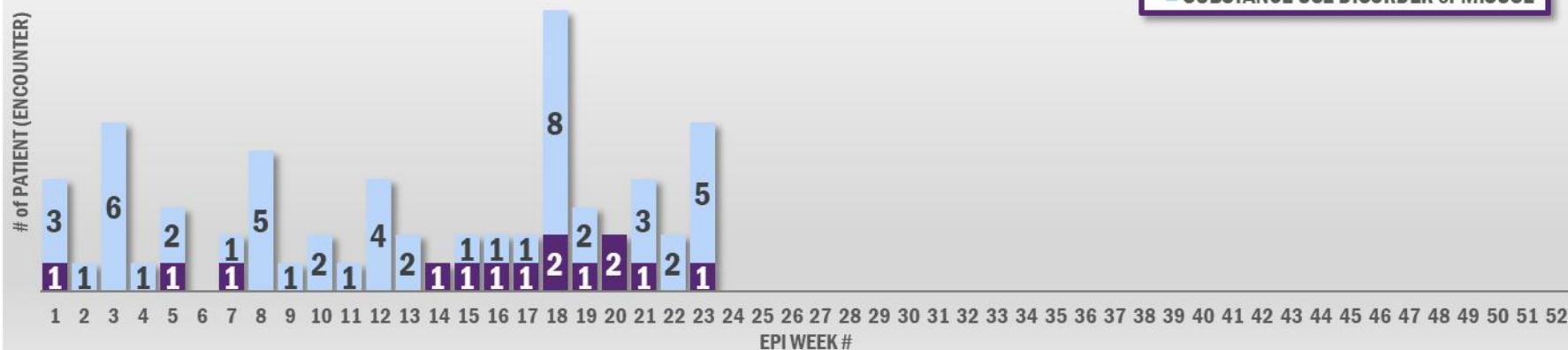

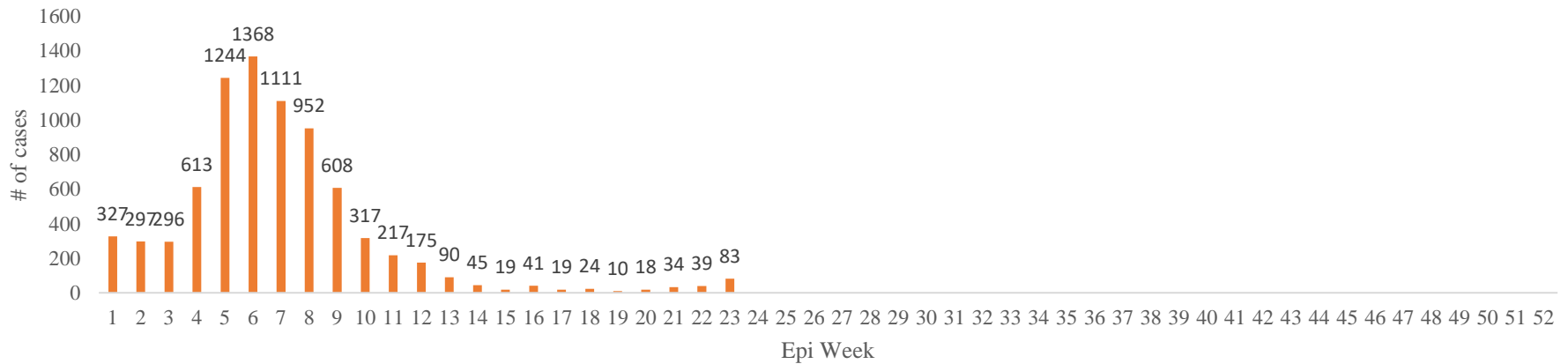

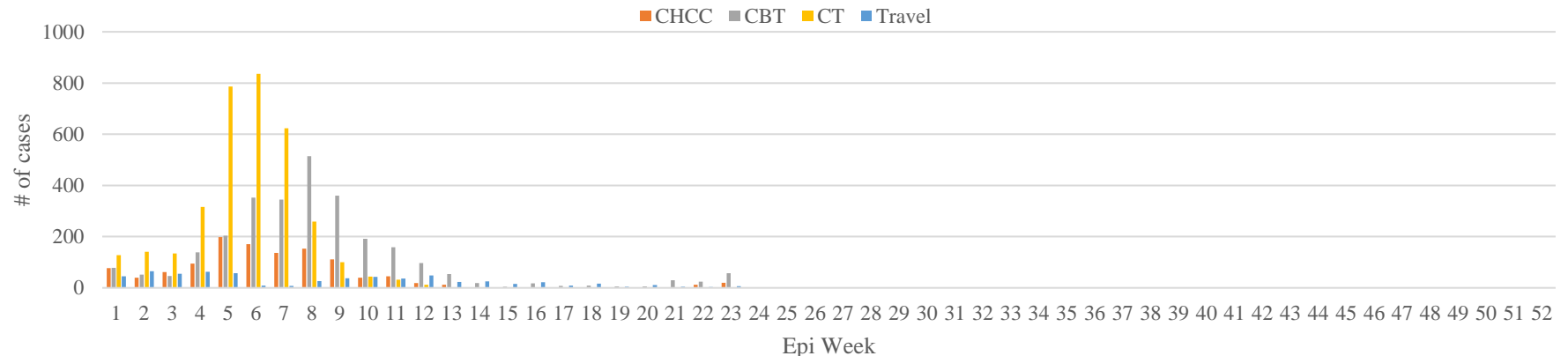
