NATURE OF WORK

This position is under the Facilities Management Department but located in the Emergency Room of the Commonwealth Healthcare Corporation (CHCC). The incumbent works under the direct supervision of the General Support Services (GSS) Manager. Must have a good command of the English language and talk in a clear, calm and understanding manner in order to place pages over the hospital public announcement and radio systems. Must be able to calmly react and relay messages in emergency situations in a timely manner.

DUTIES:

- Answer and operate telephone system to direct calls or provide information.
- Pages information over public announcement system and alerts specific individual(s) and agencies in case of emergencies.
- Maintains and updates work schedules of physicians and other on-call key personnel for prompt relaying of information.
- Checks all incoming and outgoing calls, both local and long distance to determine whether they are hospital business or should be charged to an individual.
- Log all codes and information for record keeping.
- Maintains and update telephone directories.
- Maintains an accurate and complete record of long distance and proper charge memoranda sent to the business office.
- Maintains log of pages to ensure information is expedited and not lost or non-delivered.
- Monitors, receive and places calls on local radio to proper departments.
- Performs nightly radio checks for all radio users.
- Uses paging systems to announce general public information, such as visiting hours, daily and nightly.
- Calmly, responds quickly and timely in announcing the following conditions that result in emergency medical teams reporting to give medical treatment that is life threatening to the patient as in: Code Blue, Code Red, or Code D.
- Must work 24- or 48-hours during typhoon conditions or as required by the designated supervisor.
- Log, update, and properly file Morgue Registration forms.
- Checks designated email for updates on delegations of authority and other important facility information.
- Maintains organization of logs and forms for the unit.
- Log, receive and or release security key cards/bands for staff.
- Perform other related duties as assigned.

QUALIFICATION REQUIREMENTS:

Education: High School Diploma, General Equivalency Diploma (GED), Adult Basic Education (ABE), Advance Development Institute (ADI) or equivalent.

CHCC is an equal opportunity employer. We consider all applicants for all positions without regard to race, color, religion, sex, disability, age, mental or veteran status, the presence of a non-job-related medical condition or disability, or any legal protected status.

Experience: One (1) year in Communications or related work experience.

Other: Must be willing to work any shift assigned including days, evenings, nights, weekends and holidays. Must also be willing to be “on-call” status for coverage on night shifts.

KNOWLEDGE/SKILL/ABILITIES:

- Customer and Personal Service — Knowledge of principles and processes for providing customer and personal services. This includes customer needs assessment, meeting quality standards for services, and evaluation of customer satisfaction.
- English Language — Knowledge of the structure and content of the English language including the meaning and spelling of words, rules of composition, and grammar.
- Telecommunications — Knowledge of transmission, broadcasting, switching, control, and operation of telecommunications systems.
- Clerical — Knowledge of administrative and clerical procedures and systems such as word processing, managing files and records, stenography and transcription, design forms, and other office procedures and terminology.
- Computer and Electronics — Knowledge of circuit boards, processors, chips, electronic equipment, and computer hardware and software, including applications and programming.
- Communications and Media — Knowledge of media production, communication, and dissemination techniques and methods. This includes alternative ways to inform and entertain via written, oral, and visual media.
- Active Listening — Giving full attention to what other people are saying, taking time to understand the points being made, asking questions as appropriate, and not interrupting at inappropriate times.
- Speaking — Talking to others to convey information effectively.
- Service Orientation — Actively looking for ways to help people.
- Social Perceptiveness — Being aware of others' reactions and understanding why they react as they do.
- Critical Thinking — Using logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions, or approaches to problems.
- **Reading Comprehension** — Understanding written sentences and paragraphs in work related documents.
- **Writing** — Communicating effectively in writing as appropriate for the needs of recordkeeping.

- Selective Attention — The ability to concentrate on a task over a period of time without being distracted.
- Written Comprehension — The ability to read and understand information and ideas presented in writing.

CONDITIONAL REQUIREMENTS:

Employment is contingent upon successful clearing of pre-employment health screening and drug screening in accordance with CHCC policy.

OTHERS:

This position is a Full-Time employment status and requires at least 40 hours per week. This position is “**Non-Exempt**” or is eligible to receive overtime compensation pursuant to the Fair Labor Standards Act (FLSA) of 1938 Federal Law. Regular operating hours of the Commonwealth Healthcare Corporation will be Monday to Friday from 7:30am to 4:30pm. This work schedule however is subject to change with or without notice based on the Employer’s business requirement and/or by the demands of the employee’s job. This position is paid on a bi-weekly basis (2-week period). CHCC adheres to all applicable deductions such as C.N.M.I. Tax, Federal Tax, Medicare and Social Security.

Note(s):
