#### NATURE OF WORK

Under the direct supervision of the CGC Prevention, Training, & Outreach Services Program Manager, the employee in this position will coordinate and implement outreach and training activities as part of the prevention of substance use, misuse and overdose, and promotion of mental wellness efforts for the Community Guidance Center.

#### DUTIES:

- Coordinate and conduct information dissemination, education, and community-based process activities to address the prevention of substance use, misuse and overdose, and the promotion of mental wellness for program staff, consumers, stakeholders, partner agencies, and community members.
- Coordinate and implement all activities, tasks, and responsibilities established in the program's social marketing, training, and outreach plans.
- Coordinate and implement the program's social marketing, training, and outreach plan.
- Coordinate and implement information dissemination, education, and community-based process activities to address the promotion of mental wellness and the prevention of substance use for program staff, consumers, stakeholders, partner agencies, and community agencies.
- Implement evaluation tools to monitor social marketing, training and outreach strategies.
- Collect, maintain, update, and monitor the program's training, outreach, and social marketing activities related data, including all communication outlets such as social media and emails.
- Attend in-service, online, and off-island trainings and participate in staff meetings and consultations, as required
- Prepares and submits a report to the Program Manager as required.
- Perform other related duties as assigned.

#### QUALIFICATION REQUIREMENTS:

**Education:** Any combination equivalent to an Associate's degree from an accredited college institution.

**Experience:** At least two (2) years of related experience in behavioral health or another position with the provision of community health education, social or supportive services, or related duties.

**Licenses/Certifications:** Must have a valid CNMI Driver's License.

#### KNOWLEDGE/ SKILL/ ABILITIES:

- Customer and Personal Service — Knowledge of principles and processes for providing customer and personal services. This includes customer needs assessment, meeting quality standards for services, and evaluation of customer satisfaction.

### **CONDITIONAL REQUIREMENTS:**

Employment is contingent upon successful clearing of pre-employment health screening and drug screening in accordance with CHCC policy.

### **OTHERS:**

This position is a Limited Term employment status and requires at least 40 hours per week. This position is “**Non-Exempt**” or is eligible to receive overtime compensation pursuant to the Fair Labor Standards Act (FLSA) of 1938 Federal Law. Regular operating hours of the Commonwealth Healthcare Corporation will be Monday to Friday from 7:30am to 4:30pm. This work schedule however is subject to change with or without notice based on the Employer’s business requirement and/or by the demands of the employee’s job. This position is paid on a bi-weekly basis (2-week period). CHCC adheres to all applicable deductions such as C.N.M.I. Tax, Federal Tax, Medicare and Social Security; subject to funding availability through federal funds awarded to the *Commonwealth of the Northern Marianas Islands Partnerships for Success (CNMI PFS)*, not to exceed 09/29/2026.
