NATURE OF WORK:

Under the direction of the Nurse Unit Manager, the Telemetry Technician performs duties in the Medical/Surgical Unit and is responsible for the continuous monitoring, interpretation, communication and documentation of cardiac rhythms and rhythm components. The Telemetry Technician is responsible for all telemetry-related equipment and supplies including technical troubleshooting. The Telemetry Technician is also expected to participate on nursing, hospital activities, to attend all mandated annual review programs, and to attend in-service and continuing education activities. The Telemetry Technician reports to the Charge Nurse issues with the telemetry device as identified or reported by the Telemetry Monitor Trainee.

DUTIES:

- Assists nursing staff with patient skin preparation and correct lead placement as necessary.
- Explain testing procedures to patients to obtain cooperation and reduce anxiety.
- Identifies patient's EKG rhythm and labels. Interprets and documents EKG rhythm strips each shift.
- Reports immediately all changes in baseline EKG rhythm to the primary nurse assigned to the patient and secures a strip for documentation.
- Notifies nursing staff when leads are off patient or of incorrect lead placement.
- Monitors and reviews patient information to determine baseline cardiac rhythm and prior variances
- Focuses attention to the telemetry station uninterrupted, without performing other administrative duties; ensures the telemetry station is constantly monitored by endorsing to other nursing staff if leaving station.
- Maintains a safe, clean and organized environment in the telemetry station for the unit.
- Reports malfunctioning of telemetry station to Biomed personnel for assessment and repair.
- Protects patient confidentiality and sensitive data at all times.
- Practices and applies universal precautions, isolation procedures, and physical precautions per Infection Control program. participates in staff meeting and in-services.
- Maintains effective and positive working relationships with other staff.
- Works with the Telemetry Monitor Trainee to enhance their knowledge and skills on interpreting EKG rhythm.
- Serves as preceptor to Telemetry Monitor Trainee in enhancing their knowledge and skills on interpreting EKG rhythm as needed.
- Completes annual competency evaluation for Telemetry Technicians with Continuing Education Nurse Coordinator.

QUALIFICATION REQUIREMENTS:

Education: High School Diploma, General Education Development (GED) or Advanced Development Institute (ADI). Some college credit courses or training in healthcare or nursing program with cardiac arrhythmia course is preferred.

Experience: Minimum six (6) months of work experience as certified Telemetry Technician is preferred, with some data entry experience.

Licenses/ Certification:

- Must be certified as a Telemetry Technician through training from a technical program or hospital-based program,
- Must possess Basic Life Support (BLS) Certificate from American Heart Association (AHA).

KNOWLEDGE, SKILL & ABILITY:

Proficient computer skills with working knowledge of medical terminology. Effective written and verbal communication skills.

CONDITIONAL REQUIREMENTS:

Employment is contingent upon successful clearing of pre-employment health and drug screening in accordance with CHCC policy.

OTHERS:

Regular operating hours of the Commonwealth Healthcare Corporation are Monday to Friday from 7:30am to 4:30pm, however hospital hours are 24 hours per day, 7 days per week. This position is a Full-Time employment status and requires at least 40 hours per week. The assigned work schedule is subject to change with or without notice based on the Corporation's business requirement and/or by the demands of the employee's job. This position is "**Non-Exempt**", or is eligible to receive overtime compensation pursuant to the Fair Labor Standards Act (FLSA) of 1938 Federal Law. This position is paid on a biweekly basis. CHCC adheres to all applicable deductions such as CNMI tax, federal tax, Medicare and Social Security.
