**MINIMUM REQUIREMENTS:** Bachelor's Degree in Nursing from a recognized/accredited school of Nursing or foreign equivalent, CNMI RN license and BLS or ACLS license.

**DUTIES:** Assesses, implements, evaluates and develops a written nursing plan of care. Evaluates and revises the nursing care plan as necessary to meet the stated goals. Responsible for the admission and discharge of assigned patients. Guides licensed practical nurses, graduate nurses, and certified nursing assistants. Communicate openly and effectively with members of the health care team, other professionals, patients and family members. Demonstrates current knowledge of the legal and ethical standards of nursing practice and patient care. Participates in QAPI, and CQI programs. Administers prescribed medications and treatments. Starts intravenous infusion and adds medications to IV fluids as ordered by the physician. Responsible for the total nursing care of assigned patients. Responsible for the control and administration of narcotics. Must be able to prioritize, be flexible, and manage time efficiently to accommodate workflow and variability within the unit. Ensure that medicare and other U.S. regulatory standards are applied and practiced by nursing professionals. Performs as charge nurse when assigned. Demonstrates as a preceptor or mentor as needed.
