#### NATURE OF WORK:

This position is located under the Maternal, Infant, Child, Adolescent Health (MCIAH) Immunization Program under Population Health Services, Commonwealth Healthcare Corporation; the incumbent in this position will have a direct reporting relationship to the Director of Nursing Services. This position will be responsible for overseeing the clinical components of the immunization services offered through the CHCC Immunization Clinic and will be involved in the coordinating vaccination outreach events, mobile vaccination services, training program staff and partners on vaccine recommendations, and will serve as the CHCC Perinatal Hepatitis B prevention coordinator. The incumbent in this position will function as part of the immunization program team with duties and responsibilities contributing to the overall CHCC goal for reducing morbidity and mortality, improving health outcomes by working to improve vaccination coverage throughout the CNMI.

#### DUTIES:

- Conducts nurse-client interviews and nursing diagnosis, identifying priority client needs
- Demonstrate good character and behavior which assures the provision of safe care and services
- Assumes responsibility in ensuring the environment is risks free for clients and employees
- Delivers skilled practical nursing care and participate in the delivery, monitoring, planning and evaluation of individualized patient care in relevant areas of practice
- Provides nursing interventions such as health teaching, medication teaching, lifestyle counselling, coping enhancement and anxiety reduction
- Provides nursing therapeutics such as medication administration, dressing changes and irrigations
- Provides information, resources, and or personnel assist to clients
- Conducts unit in-services to upgrade staff's nursing knowledge and clinical skills on an ongoing basis, including vaccine administration and vaccine preventable diseases.
- Administers VFC and 317 funded vaccines, provides vaccine information statements, and enters information into patient electronic health record and WebIZ system.
- Works with hospital, health and vital statistics office, CHCC Women's Clinic, HIV/STD program and other relevant public health staff to coordinate activities and data collection for Perinatal Hepatitis B Prevention.
- Maintains, updates, and implements policies on Perinatal Hepatitis B.
- Conducts follow-up on all infants born to HBsAg positive women to assure prophylaxis, timely dosing, and PVST, and complete required reports including the Perinatal Hepatitis B annual report in the CDC PAPA system.

- Collaborates with other team members for adequate coverage of the unit
- Be able to prioritize a constantly changing workload along with meeting patients' demand ensuring both the clinical and safety of patients are not compromised.
- Able to float to other units as assigned to perform basic nursing duties such as taking vital signs and assisting physicians
- Performs other duties as assigned

#### **QUALIFICATION REQUIREMENTS:**

**Education:** Associates degree in Nursing from a recognized/accredited school of Nursing or foreign equivalent.

**Experience:** No experience required.

**Licensure/ Certification:** Must pass the NCLEX- RN and must be licensed as a Registered Nurse by the Commonwealth Board of Nurse Examiners (CBNE) to practice nursing in the Commonwealth of the Northern Mariana Islands (CNMI). Must possess BLS and/or ACLS Certificates.

#### **KNOWLEDGE, SKILL & ABILITY:**

- Ability to communicate openly and effectively with members of the health care team, patient's family members and patients; must be organized; knowledge of basic computer skills preferred but not required.
- Database administration, including user account maintenance, creating custom objects, running reports, and troubleshooting problems.
- Strong communications skills with demonstrated experience presenting data cross-functionally.
- Proven team player, delivery-focused, yet flexible and creative when called upon.
- Work collaboratively with staff to determine what data are necessary to measure outcomes critical to the organization and how the data should be reviewed, analyzed, and acted upon on a regular basis.
