NATURE OF WORK:

Under the general supervision of the Medical Referral Coordinator/Officer-In-Charge, the employee in this position performs as a driver for miscellaneous field work; transporting patients and escorts for their medical appointment and treatment, assists patients and escorts with their official needs/requirements. Other related duties and responsibilities for the Medical Referral Guam Office, Commonwealth Healthcare Corporation.

DUTIES:

- Meets patients and escorts to assist on their transfer and makes sure that the transfer is safe and timely.
- Assists patients and escorts in their official needs/requirements.
- Makes ambulance and airline arrangement when needed.
- Makes arrangements for ground transportation for all out-patients and family escorts to health and/or hospital facilities for necessary treatment.
- Makes appointments for referral patients.
- Prepares travel documents as required.
- Acts as interpreter for patients and doctors.
- Maintains the medical referral vehicle(s).
- Submits report on fuel usage and mileage readings of assigned vehicle(s) to office.
- Must work on-call as scheduled and be available when assistance is needed.
- Assists in the office with administrative matters when needed.
- Performs other related duties and responsibilities as assigned.

QUALIFICATION REQUIREMENTS:

Education: High School Diploma or equivalent certification of basic adult education accomplishment.

Experience: Three (3) years of non-emergency medical transportation driving experience or professional related experience.

Licenses/ Certifications: Must have a valid Driver's License.

CONDITIONAL REQUIREMENTS:

Employment is contingent upon successful clearing of pre-employment health screening (Covid-19 vaccine required) and drug screening in accordance with CHCC policy.

OTHERS:

This position is a Full-Time employment status and requires at least 40 hours per week. This position is “Covered”, or is eligible to receive overtime compensation pursuant to the Fair Labor Standards Act (FLSA) of 1938 Federal Law. Regular operating hours of the Commonwealth Healthcare Corporation will be Monday to Friday from 7:30am to 4:30pm, however facility hours are 24 hours / 7 day per week. The **Field Staff** position will be required to work a fixed work schedule; incumbent can opt to have a Compressed Work Schedule enabling full-time employees to complete basic 80-hour bi-weekly work requirement in less than 10 days. This work schedule however is subject to change with or without notice based on the Employer’s business requirement and/or by the demands of the employee’s job. This position is paid on a bi-weekly basis (2-week period). CHCC adheres to all applicable deductions such as C.N.M.I. Tax, Federal Tax, Medicare and Social Security.

Note(s):
