#### DUTIES:

- Assesses, implements, evaluates and develops a written nursing plan of care.
- Evaluates and revises the nursing care plan as necessary to meet the stated goals.
- Responsible for the admission and discharge of assigned patients.
- Oversees LPNs, GNs, and NAs.
- Communicate openly and effectively with members of the health care team, other professionals, patients and family members.
- Demonstrates current knowledge of the legal and ethical standards of nursing practice and patient care. Participates in QAPI, and CQI programs.
- Administers prescribed medications and treatments.
- Starts intravenous infusion and adds medications to IV fluids as ordered by the physician.
- Responsible for the total nursing care of assigned patients.
- Responsible for the control and administration of narcotics.
- Must practice safe and sound nursing judgments in providing care for assigned patients.
- Must be able to prioritize, be flexible, and manage time efficiently to accommodate work flow and variability within the unit.
- Ensure that Medicare and other US regulatory standards are applied and practiced by nursing professionals. Performs as Charge Nurse when assigned.
- Demonstrates as a preceptor or mentor as needed.
- Performs other related duties or tasks as needed.

#### QUALIFICATION REQUIREMENTS:

**Education:** Associates degree in Nursing from a recognized/accredited school of Nursing or foreign equivalent.

**Experience:** No experience required.

**Licensure/ Certification:** Must pass the NCLEX- RN and must be licensed as a Registered Nurse by the Commonwealth Board of Nurse Examiners (CBNE) to practice nursing in the Commonwealth of the Northern Mariana Islands (CNMI). Must possess BLS and/or ACLS Certificates. NRP and/or PALS Certificates, as required by assigned unit.

**CONDITIONAL REQUIREMENTS:**

**OTHERS:**

This position is a Full-Time employment status and requires at least 40 hours per week. This position is “Exempt” or is not eligible to receive overtime compensation pursuant to the Fair Labor Standards Act (FLSA) of 1938 Federal Law. Regular operating hours of the Commonwealth Healthcare Corporation will be Monday to Friday from 7:30am to 4:30pm, however facility hours are 24 hours / 7 day per week.
