Sanitary inspections of food establishments for July 2022

During the month of July, the Commonwealth Healthcare Corporation (CHCC) Environmental Health Disease Prevention (EHDP) conducted sanitary inspections on retail, eating, and drinking establishments. Through this release, EHDP is providing (a) names of establishments by inspection grade, and (b) names of establishments which were ordered to close for serious violations of health and sanitation standards. For these establishments, the suspension date and the date they were certified to resume operations are provided.

Classifications for Food Safety Rating for an establishment receiving a score of:

- 0-10 Demerits Grade A
- 11-20 Demerits Grade B
- 21-30 Demerits Grade C
- > 30 Demerits Closure/Suspension
